4. Impact on Cumballa Hill due to Redevelopment

Capt. Batra brought up the topic of damage to our hill due to excessive redevelopment. What would be the impact due to excessive construction? How would the road take excessive traffic and most importantly, where would we get water to cater to these monstrosities?

Mr. S. Behl said that the entire area of the western Ghats is fragile. The changes affecting all of us is climate change, urban heating and underground heating. Underground heating increases due to the depth of the digging to lay the foundation of the skyscrapers. Does our hill have the capacity to take this load? Mumbai has water supply from 7 lakes and water would will become a major issue. Dr. Soonawalla stated that we create awareness and restrict the height and depth of the buildings. Capt. Batra said that we should find out other groups dealing with similar issues and join forces with them to make a combined effort.

Ms. Gupta said that we should write to all the societies to make them aware of the problem. Mr. awatramani was of the opinion that we should have a holistic approach to this subject.

5. Public Interest Litigation

The matter was initiated 12 years ago in 2012. The progress has been extremely slow.

6. TT Tournament

Mr. Farhad Cooper initiated a TT Tournament for our area with the help of Ms. Mamta Gupta and Ms. Rita Sethi. It was a success and we plan to organize a few more activities.

7. Ambani Security

Mrs. Ashokkumar stated that on a couple of occasion when she was walking on the road the Ambani security has been extremely rude. This complaint has been received by us from other residents as well. The matter will be taken up with Antilla to tell them to sensitise their security staff.

8. Bank of India

Mrs. Swati Tyagi, the manager talked of the services provided by them. She also introduced her other staff members.

There being no other item, the meeting was terminated with a vote of thanks to the chair and to the Residents of Olympus Co-op Society.
